

## **FUNDING SOURCES**

Individually or in cooperation with each other, the four participating municipalities could obtain Federal, State, County, foundation, and private funding to leverage their own capital funds to implement the improvements contemplated in this Feasibility Study. The following is a list of principal funding sources (for implementation and programming); it is by no means all-inclusive.

### **Federal Grants and Federally-Funded/State-Administered Grants**

- Pennsylvania Department of Conservation and Natural Resources, Pennsylvania Recreational Trails Program Grants provide funds to develop and maintain recreational trails and trail-related facilities for motorized and non-motorized recreational trail use. Match requirements are 80% grant money, up to a maximum of \$100,000, and 20% project applicant money. Acquisition projects require a 50/50 match. Funding is provided through the Federal Highway Administration.

Through this program, federal funding is available for provision of facilities for pedestrians and bicycles, provision of safety and educational activities for pedestrians and bicycles, acquisition of scenic easements and scenic or historic sites, landscaping or other scenic beautification, historic preservation, and preservation of abandoned railway corridors.

### **State Grants**

Though highly competitive, these grants are available without a maximum limit to the amount, but require at least a 50% match.

### **Technical Assistance Grants:**

- Education and Training – to provide assistance by recreation and park advisors to communities, sponsor workshops, and provide publications

Acquisition Grants:

- Park and Recreation Areas – to purchase land for park, recreation, and conservation purposes
- Rails-to-Trails – to purchase abandoned railroad rights-of-way for public recreational trail use and purchase adjacent land for access or related support facilities

Development Grants:

- Park Rehabilitation and Development – to rehabilitate existing parks and indoor and outdoor recreation facilities, and to develop new park and recreation areas
- Greenways and Trails – to rehabilitate existing and develop new greenways and trails
- Rails-to-Trails – to rehabilitate and develop abandoned rights-of-way and support facilities for public recreational trail use

County Grants

- Lancaster County Urban Enhancement Fund, through the Lancaster County Planning Commission, provides a maximum of \$250,000 in funding requiring a 67% match. Meanwhile, Municipal Transportation Grant Program of Lancaster County provides up to 50/50 matching grants to projects in the categories of congestion reduction,

safety, and non-motorized transportation. Eligible applicants include municipalities, Red Rose Transit Authority, the Lancaster Airport Authority, and the Lancaster County Transportation Authority.
